Unless otherwise stated, no bidder may withdraw their bid within a period of sixty (60) days after the date set for the reply date.
2. If prices are quoted FOB Edwardsville IL., delivery to Edwardsville CUSD No. 7 locations shall be without additional charge.
3. Failure to examine any drawings, specifications, and instructions will be a bidder's risk. If bidder is in doubt as to the true meaning of any part of the drawings, specifications and instructions or other documents, they should submit a written request for an interpretation to the Chief Financial Officer. An interpretation of the documents will be made only by addendum issued by Chief Financial Officer to each firm to whom a request for bid was forwarded. Edwardsville CUSD No. 7 will not be responsible for explanations or interpretations of the bid document except as issued in accordance herewith.
4. Where a brand or trade name appears in the specifications, it is understood that the brand or trade name referred to, or its equivalent, shall be furnished. If no mention is made of any exceptions, it is assumed that bidder is bidding on the article mentioned and not an equivalent.
5. The bidder is requested to attach brochure-type information on the supplies furnished. All guarantees and warranties should be clearly stated.
6. Edwardsville CUSD No. 7 is exempted from Federal excise taxes and state and local sales taxes and bidders must quote prices which do not include such taxes. An exemption certificate will be furnished upon request.
7. Bids and modifications or corrections thereof received after the closing time specified will not be considered. Edwardsville CUSD No. 7 is not responsible for delays in delivery by mail, courier, etc.
